### *Academic Affairs Reorganization Opportunities*

GCC Colleagues,

I want to share an update about ongoing work that our faculty leaders have undertaken to explore the organization of our Academic departments. This work may lead to program growth and collaboration in alignment with our new strategic plan and the needs of the West Valley. This past Fall, faculty leadership discussed a potential reorganization of Academic Affairs as a way to examine our organizational structures and consider how we might leverage our resources to promote efficiencies and innovation at GCC. Given the newly evolving budget reallocation model, this strategy is now even more timely. In response to initial discussions this Fall, both our VPAA and I encouraged faculty leaders to move forward in consideration of a potential reorganization of Academic Affairs. In response, the Faculty Senate and Faculty Chairs voted to engage in a discussion and launched a committee to continue this work. Although reorganization, particularly at this early stage of discussion, may concern some, I am also hopeful that this work will allow us to dream big for the future of GCC and our students. I fully support the work of the Academic Reorganization Committee and I am looking forward to reviewing its recommendations.
